



HISTORICAL MARKET SHARE AND VOLUME PER MARKET



























QUALITY OF AVAILABLE LIQUIDITY PER VENUE

Big xyt definitions:

- Size contribution EBBO both Ratio between the cumulative bid and ask sizes at a given exchange and the cumulative EBB and EBO sizes (contribution of BO size at a given exchange to overall EBBO size). Bid has to be equal to the EBB and ask equal to the EBO. For daily aggregation the ratio is weighed by time.

- Presence EBBO Both % calculates the percentage of time (in millisecond resolution) that particular exchange has both bid and ask not worse than corresponding products/exchanges in the relation to time period that combined bid and ask across all exchanges (EBBO) exists. - Presence EBBO Both Exclusive % calculates the percentage of time period (in millisecond resolution) that a particular exchange has both bid and ask not worse than corresponding products/exchanges and additionally either bid or ask is on the best level. Metric is calculated in the relation

to the time period that combined bid and ask across all exchanges (EBBO) exists. -Spread at Touch calculates the observed bid-offer spread of every single quote (BBO). This spread is a relative measure in relation to the mid price expressed in basis points (0.01%).
